(2) The Club is not the only available provider of group organized services and activities related to road and trail motorcycle / ATV riding. There are numerous other motorcycle / ATV clubs and groups available to me in the Maryland, Virginia, West Virginia, District of Columbia, Pennsylvania, and Delaware areas which I can try to join for purposes of road and trail motorcycle / ATV riding, social events, and other activities related to motorcycling / ATVing. Additionally, motorcycle / ATV events and activities can be engaged in and enjoyed without joining the Club or any organized club or group.

(3) Road and trail motorcycle / ATV riding are extremely dangerous activities and involve the risk of serious injury and/or death and/or property damage, which can occur due to the negligent acts or omissions of myself, other persons, and/or organizations connected with the conduct of such activities. Road and trail motorcycle / ATV riding requires specialized skill, experience, and equipment. I am solely responsible for assessing my own abilities, skill, experience, equipment, and terrain when participating in any and all Club related activities. I am responsible for obtaining my own private insurance to compensate and protect me from injuries, personal and property, which may occur as a result of my participation in Club related activities. **I VOLUNTARILY ASSUME ALL RISKS OF SERIOUS INJURY AND/OR DEATH AND/OR PROPERTY DAMAGE, WHETHER CAUSED BY MY OWN NEGLIGENCE OR THE NEGLIGENCE OF THE CLUB, ITS OFFICERS, MEMBERS, GUESTS, AGENTS, EMPLOYEES, PROMOTERS, ORGANIZERS, LAND OWNERS UPON WHICH CLUB RELATED ACTIVITIES OCCUR, AND THOSE ACTING IN THEIR SUPPORT OR ON THEIR BEHALF, (HEREINAFTER REFERRED TO COLLECTIVELY AS "THE RELEASEES"), OR OTHERWISE, TO MYSELF OR MY PROPERTY AS A RESULT OF MY PARTICIPATION IN CLUB RELATED ACTIVITIES.**

(4) **I HEREBY RELEASE, WAIVE, AND DISCHARGE THE RELEASEES AND EACH OF THEM, FROM ALL LIABILITY TO ME, AND I COVENANT NOT TO SUE THE RELEASEES AND EACH OF THEM, FOR ANY LOSS OR DAMAGE AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO MY PERSON OR PROPERTY OR RESULTING IN MY DEATH, WHETHER CAUSED BY MY OWN NEGLIGENCE, THE NEGLIGENCE OF THE RELEASEES, OR OTHERWISE, WHILE I AM ENGAGED IN CLUB RELATED ACTIVITIES. THIS PARAGRAPH IS BINDING ON MY HEIRS, EXECUTORS, ASSIGNS AND ADMINISTRATORS.**
